Important Dates!

September

6th - *FINAL DATE for Submissions*. We will not accept late entries.

20th- Final Date for Revised Submissions. *This is only for those that have been accepted and asked for revisions to meet the vision of the project.

October

21st - Pot Painting Day – Full Day (Times TBA)

22nd- Pot Painting Day – Full Day (Times TBA)

*Please note, these will be the only dates allowed for painting. All painting will take place on site at the Walker St. facility. Painting day details will be sent out closer to date.

Project Specifics:

This project is intended for artists of professional skill level and those who simply have not been discovered yet. It is however designed with a professional art feel as it will be displayed in a central focal point of Downtown Houston. All entries are welcomed and will be viewed individually.

Artists will need to complete the following for *EACH* pot they wish to be selected for: (Artists will only be selected for one pot.)

The following is all due in one submission by September 6, 2019.

- Submit a participant waiver (included in this packet)
- Submit a completed rendering including color
- Use some of the Public Works new branding color palette in their art (specs provided in this packet)
- Submit a request for all supplies needed in order to complete the painted pot (We will provide all supplies necessary within reason and compared to other requests.)
- Submit a brief bio (up to 250 words) and website link (if you have one) to be added to the KHB website page featuring this project

The Pots

Size and Look of the Pots

Following are images of the pots with height and width measurements. The pots will be pre-coated with a solid color from the new branding color palette. The upper lip of the pot will remain solid in color and are not to be included in your design.
